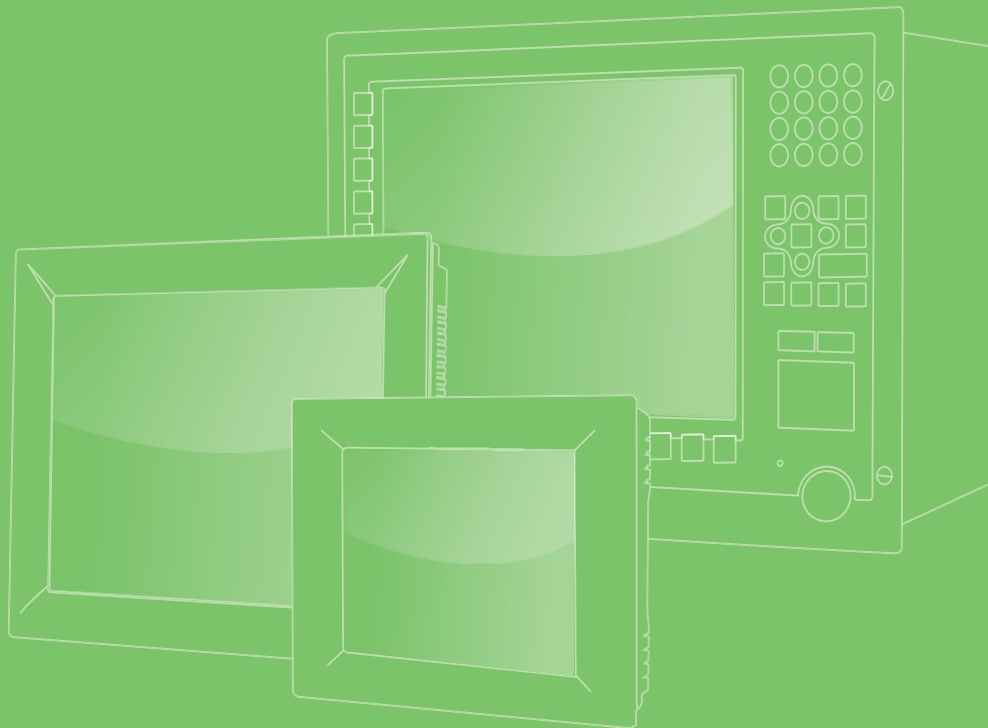

1.1 Introduction

FPM-800S series is a rugged and reliable industrial monitor, which supports wide-temperature operation that make it suitable for many applications. True flat IP66-rated front gives it an elegant outlook and it also provides protection from water and dust intrusion making daily cleaning easier. With support for wide temperature operation ranges (-20 ~ 60°C / -4 ~ 140°F) and 304 grade stainless steel front bezel, FPM-800S is especially suitable in hygiene-demanding and hazardous environments.

1.4 Connectors

The following connectors are situated on the bottom side of the FPM-800S series:

- **VGA Port (DB-15)**
DB-15 connector can be connected to the system via the external 15-pin DB-15 connector located on the left side of the system unit.
- **Touchscreen Connector (USB)**
This connector will be present only if a touchscreen is installed. It must be connected to the USB port of the PC. The touchscreen cable is included with all orders.
- **DC 24V Power Input Connector**
This connector must be connected to DC 24V power switch.

Please note before connecting the monitor and PC with a VGA cable:

1. *If your PC has an OS installed, please confirm its refresh frequency is within the acceptable range.*

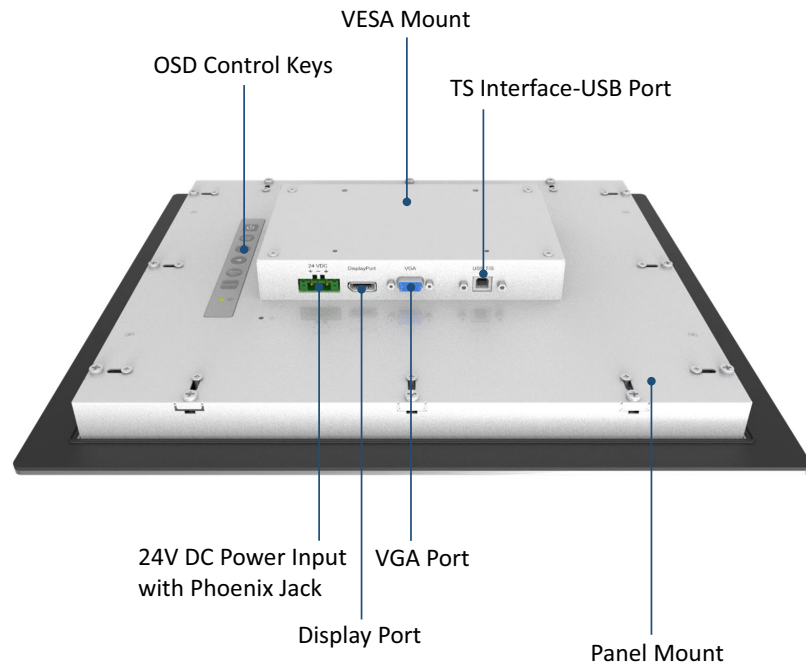
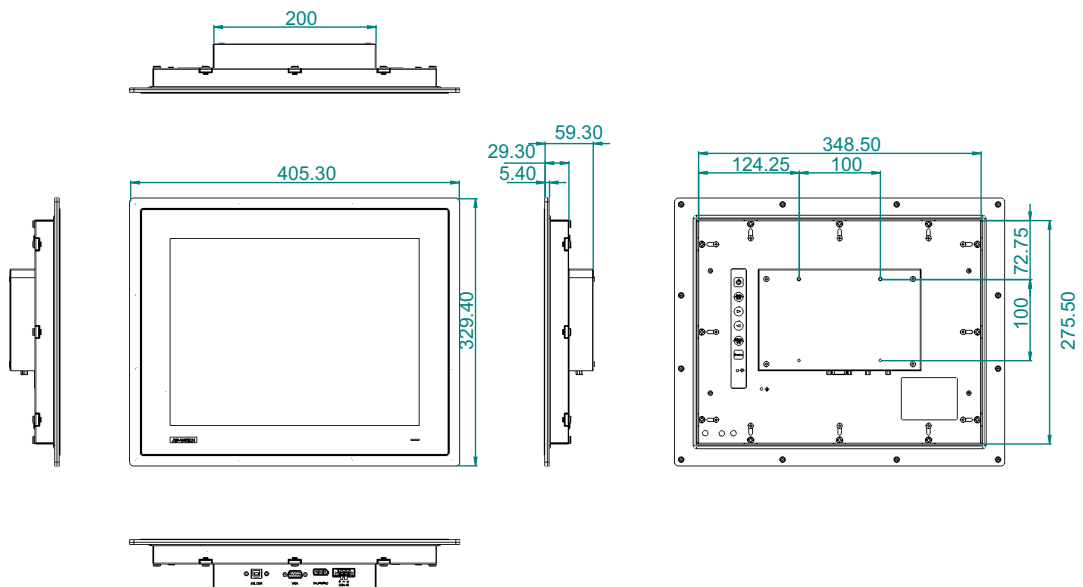


Figure 1.1 FPM-800S - I/O Port Arrangement

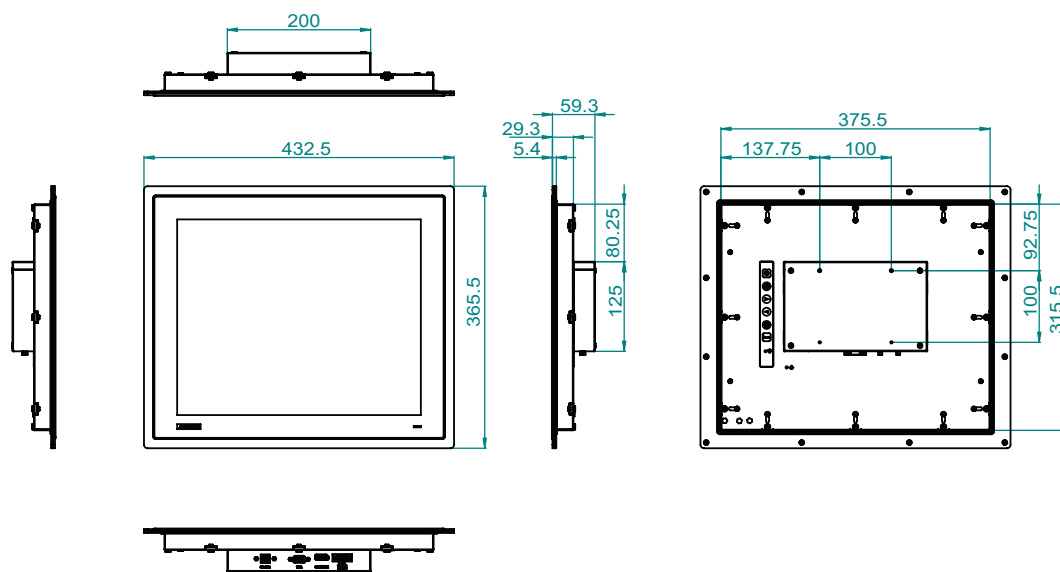

2.1 Mounting the Monitor

The FPM-800S series can be mounted for Panel, wall, desktop, VESA arm.

2.1.1 Panel Mounting

If you need to install the FPM-800S series in a panel, please put the monitor into the cabinet then roll out the clampers and fix them with screws. To implement the panel mount completely, it required 12 clampers with M4 * 25mm screws.

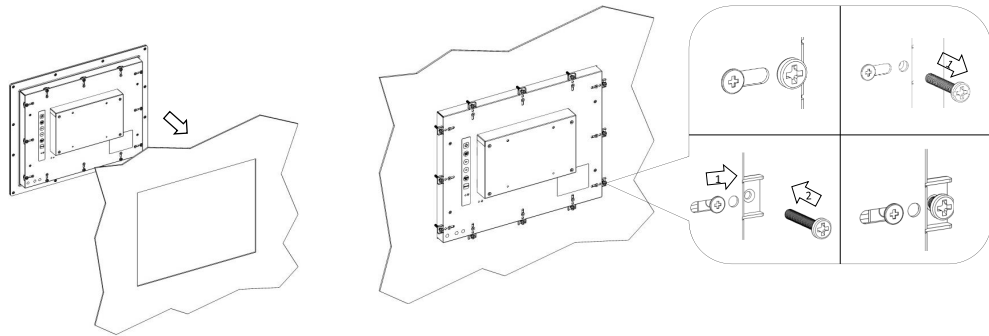


Figure 2.1 Panel Mounting

If you need to install the FPM-800S series in the wall, you can use FPM-1000T mounting kit which is offered as an optional accessory for FPM-800S. You need to secure this metal bracket to the wall first then fasten the FPM-800S with the included screws. The metal bracket holds the FPM-800S to the wall to complete the wall mounting.

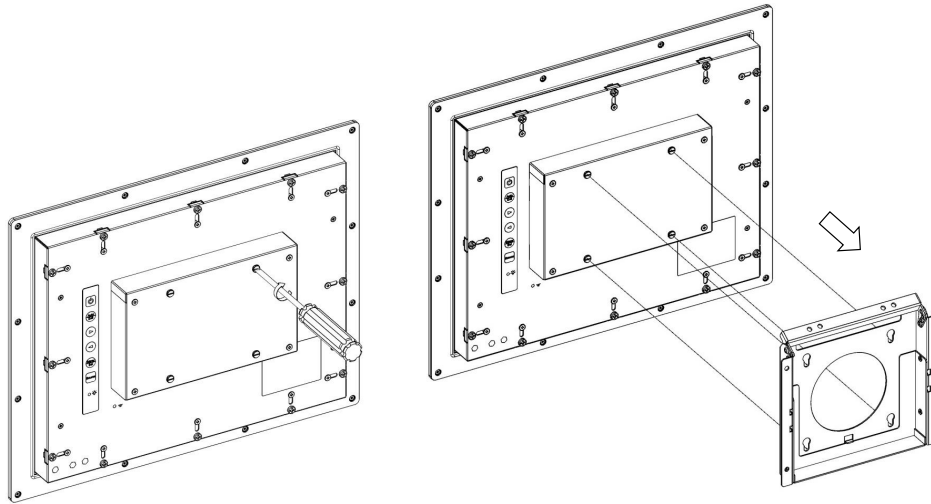


Figure 2.2 Wall Mounting

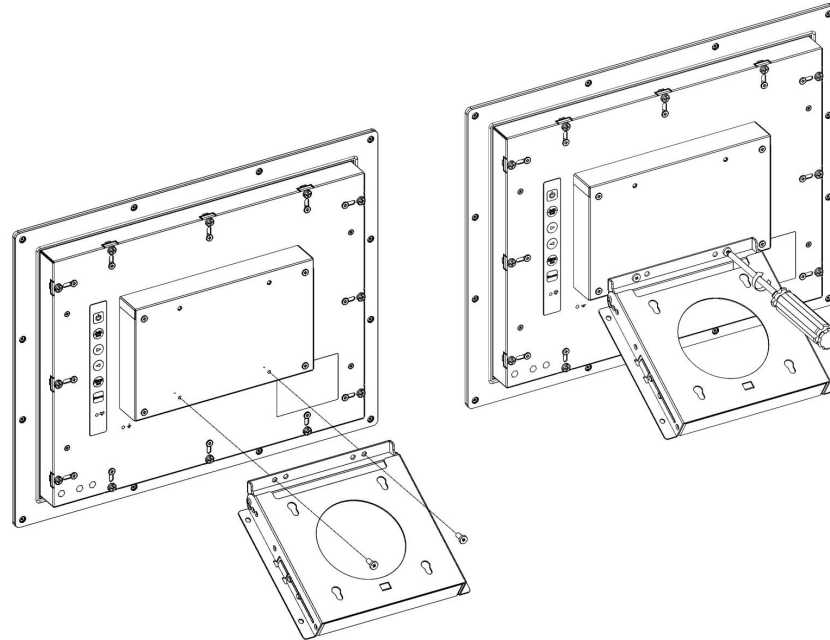


Figure 2.3 Desktop Stand Mounting

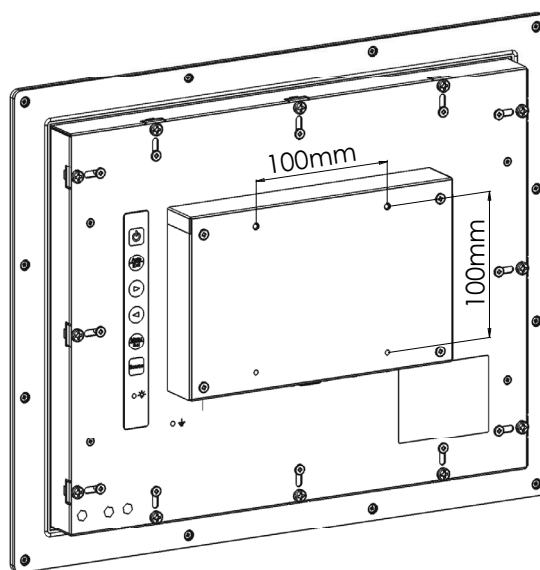


Figure 2.4 VESA Mounting

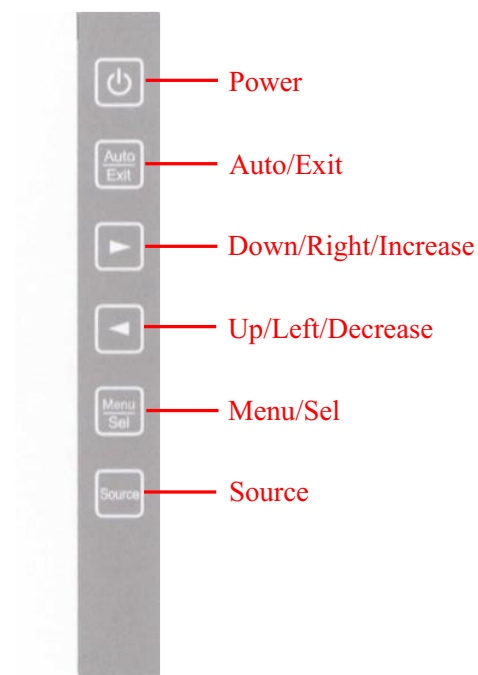
